On the receipt of the information a police team reached the spot and started investigation. The deceased was identified as Suresh Kori.

Woman among 4 held for property document fraud

Habibganj police have booked four persons including a woman for fraudulently producing documents to transfer ownership of half part of a house at Arera Colony; case is registered on the orders of court after it was found that the deed produced by the accused was forged.

Police said that the victim Anshu Ranjan Agnihotri filed a case in the court regarding producing of forged documents of property to transfer half of their patriarch house at Arera Colony.

The victim claimed that his brother-in-law Girish Kumar Tiwari, his daughter Hemani, Vinod Tiwari and Bal Kishan produced fake will of his father to claim half of the house which is owned by him and using the fake will the accused

tried to transfer ownership of half of the house. After the court found that the documents produced by the accused were wrong while the claims made by the victim were true orders were issued by the court to register case of fraud against the four accused.

Based on the orders issued by court on Thursday the police have registered a case under section 420, 467, 468, 471 and 120 B of the IPC against Girish Kumar Tiwari, his daughter Hemani and two witnesses Vinod Tiwari and Bal Kishan who were involved in facilitating the producing of documents and started further investigation.

Police said that the accused are yet to be quizzed in the case as the case was registered on Thursday and the accused have to be contacted for the further investigation.
